# **Island City Yard Sale**

## **Saturday, March 14, 2020**

**Hagen Park, 2020 Wilton Drive, Wilton Manors, FL.  
8:00am - 2:00pm**

The City of Wilton Manors will host four (4) yard sales in the 2019– 2020 season. The dates are: **November 9<sup>th</sup>, December 14<sup>th</sup>, January 11<sup>th</sup>, February 8<sup>th</sup> & March 14<sup>th</sup>**. All registrations **must be paid by 1:00pm on the Monday prior to the sale.**

**TO REGISTER:** Complete the registration and release form on the back of this flyer. Mail with a check payable to the City of Wilton Manors to: Wilton Manors Yard Sale, 2020 Wilton Drive, Wilton Manors, FL 33305, or come to Hagen Park, 2020 Wilton Drive, Wilton Manors, between 7:30am-9:00pm Monday – Thursday; 7:30am – 6:00pm Friday; or 8:00am – 12:00pm on Saturday, and complete the form and pay. Payment can be made by cash, by check, VISA or Master Card.

***You may select any combination of two size spaces.***

### **OUTDOOR SPACES:**

1. A mini – car/van space is 18' X 15' (two regular size car parking spaces) where you may park your car/van and set-up in the extra space or use both spaces for your sale product set-up. **A shade tent is allowed in a car/van space. (Must have weights to properly tie down tents)**
2. A car/van space is 27' X 15' (three regular size car parking spaces) giving you room for more than one vehicle and/or double and/or triple the set-up space. **A shade tent is allowed for a car/van space. (Must have weights to properly tie down tents)**
3. 10' X 10' Space on the basketball court. **No vehicles are permitted on the basketball court at any time. This includes during setup and breakdown. A shade tent is allowed in a car/van space. (Must have weights to properly tie down tents)**

**SPACE ASSIGNMENT:** Spaces are assigned on a first come first serve basis. All car/van spaces are assigned based on date of registration unless you come regularly and have a reserved space. All space assignments will be mailed or emailed to you the week of the event. ***For those vendors who have a regularly reserved space, the registration must be paid three (3) weeks prior to the sale to guarantee that space.***

**TABLES:** Tables may be reserved for the event or you may bring your own tables. Please reserve and pay for any tables when pay your space fee. We will not guarantee availability of tables if you register the week or day of the event.

### SALE RULES:

1. **Set up hours are from 5:30am-7:00am** Saturday the date of the sale. Sale is from 8:00am-2:00pm. **Break down time is from 2:00pm-3:30pm. All rental tables must be cleared by 3:00pm.**
2. All vendors **must operate from 8:00am-2:00pm. You may not break down early.**
3. All vehicles must be removed from sale area by 7:30am on sale day unless you have purchased a space which includes a vehicle. Vehicles will be allowed in sale area again until 2:00pm.
4. **No vehicles are allowed in the show from 7:30am – 2:00pm unless they are parked in an approved car space.**
5. **Space fees are not refundable or transferable at any time (which includes weather or any other act of nature).**
6. Management reserves the right to remove any vendor at any time for any cause felt to be in poor taste or not complying with the law or rules of the show,. This may also include future sales.
7. City does not allow the sale of "adult" videos, sexual publications or paraphernalia, or any promotion of the use of illegal drugs at the City sponsored Yard Sale.
8. **Vendors are responsible for removing all trash and remaining articles from sale area after the show is over.**
9. Vendors must not drive nails into or otherwise damage concrete, asphalt, canopies, table or other property.
10. Vendors that don't arrive by 7:00am will forfeit their space.
11. Vendors with a basketball court space may not drive their vehicles on the court.

### **I understand and agree to abide by the sale rules as stated above and on the back side of the flyer.**
